Background

According to the <u>Regional Baltic Marine Spatial Planning Roadmap 2013-2020</u> (point 4.1) and the <u>HELCOM-VASAB MSP WG Work Plan 2014-2016</u> the HELCOM-VASAB MSP WG is to identify competent contact points for MSP for the purpose of transboundary consultation and joint planning. The HELCOM and VASAB Secretariats are to keep the list updated.
