Background

HELCOM and VASAB are co-coordinators of Horizontal Action (HA) Spatial Planning of the EU Strategy for the Baltic Sea Region (EUSBSR). The joint HELCOM-VASAB MSP Working Group acts as the steering committee for the HA Spatial Planning concerning MSP issues. Both Secretariats assist the WG in this role, by e.g. keeping the group informed of activities related to the (EUSBSR) and HA Spatial Planning (such as funding opportunities and meetings) and representing the HA in various meetings and processes as needed.

Developments and activities related to the EUSBSR and HA Spatial Planning October 2018

HELCOM and VASAB are co-coordinators of Horizontal Action (HA) Spatial Planning of the EU Strategy for the Baltic Sea Region (EUSBSR). The joint HELCOM-VASAB MSP Working Group acts as the steering committee for the HA Spatial Planning concerning MSP issues. Both Secretariats assist the WG in this role, by e.g. keeping the group informed of activities related to the (EUSBSR) and HA Spatial Planning (such as funding opportunities and meetings) and representing the HA in various meetings and processes as needed.

EU activities concerning macro-regional strategies

EC is going to initiate the Revision process of the EUSSBR Action Plan by the end of 2018 in order to provide a relevant update before the new programming period 2021-2027 starts. Revision will consider achievements and challenges for both thematic and governance issues, the relevance of Strategy's objectives, sub-objectives and targets, as well as set the future tasks. The revision is expected to be more coherent with other macro-regional strategies, EU policy and funding priorities. The timeline for the revision is set quite ambitious with goal to finalize the process by autumn 2019. In this regard the external expert is expected to be hired by EC in the beginning of 2019. However, EUSBSR thematic coordinators will have an important role in revision. Taking into account that majority of the strategic targets are set with timeline by 2020/2021, strategic goals within thematic areas could be reconsidered.

The strategic goal of the HA "Spatial Planning" is to draw up and apply transboundary, ecosystem based maritime spatial plans throughout the Baltic Sea region by 2020/2021. Current work on follow-up of the regional MSP principles, guidelines and Regional Baltic MSP Roadmap can be valuable and timely input to the EUSBSR update process.

Follow-up on funding activities

First developed as a pilot initiative for the Danube Region in 2016, the updated online platform "EuroAccess" (www.euro-access.eu), covering all four EU macro-regional strategies, was launched on 25th June 2018. The platform is an online information and search tool on EU-funding available in four EU Macro-Regions in order to help people and organisations with project ideas find suitable sources of EU funding.

Interreg BSR Programme – within the 3rd (and final) Call (open from 5 October 2017 till 9 April 2018) one project application of ICM relevance was approved - "Land-Sea Interactions Advancing Blue Growth in the Baltic Sea Coastal Areas" (project lead - Latvian Ministry of Environmental Protection and Regional Development). The project was prepared with support of the EUSBSR Seed money project "Land-Sea-Act" and has received the Letter of Support on 6th April 2019 on behalf of VASAB Secretariat.

Within the Interreg BSR Programme the 2nd Call for the project platforms has been launched from 2nd October 2018 till 31 January 2019 to combine projects for more impact, more intensive use, better durability and transferability of the projects' outcomes in the following topics:

- · Research and innovation infrastructures,
- · Smart specialisation,
- · Marine litter management,
- Management of marine space (capacity building of public authorities & practitioners for more integrated & safe management of marine space & strengthened MSP across the borders),
- Climate change adaptation and mitigation.

The core of project platforms shall be built by at least 2 ongoing or accomplished Interreg Baltic Sea Region's projects and at least one project from other funding programme.

VASAB together with HELCOM, Maritime Institute in Gdansk (PL), Swedish Agency for Marine and Water Management (SE), Aalborg University (DK), Latvian Ministry of Environmental Protection and Regional Development (LV) is preparing an application for MSP projects platform.

Within the Interreg BSR Programme the 1st Call for the extension stage projects has been launched from 2nd October 2018 till 31 January 2019. The extension stage is an instrument of the Programme to flexibly support successful regular projects in the capitalisation of their earlier results and partnerships. The extension stage offers a possibility for the finalised regular projects to receive additional funding for the implementation of specific activities that would

strengthen the utilisation of the outcomes of the main stage project and increase the quality and durability of the preceding regular projects.

Interreg Central Baltic Programme (EE, LV, SE, FI, Åland) – the **4**th **Call** is open from 15 October till 16 November 2018. The 4th call is targeted only to the opened Specific Objectives (SO 1.1., SO 1.3., SO 2.1 (sustainable tourist attractions), SO 3.1 (transport flows of people and goods), SO 4.1). The Steering Committee will make the decision on 4th Call projects in March 2019.

Interreg South Baltic Programme 2014-2020 (DE, DK, LT, PL, SE) - 6th Call is opened between 1 October - 18 December 2018 for the Specific Objectives: 2.2 (green technologies), 3.1 (sustainability of transport services), 4.1 (skilled labour force in blue & green economy sectors) and 5.1 (cooperation capacity). The Monitoring Committee's decision on the approval of projects submitted under the 6th call for proposals is expected in April 2019

Interreg Europe – 4th Call for proposals for interregional cooperation projects was open between 7 May - 22 June 2018 for all thematic priorities and all remaining ERDF funding (~74 mil EUR). The strategic and operational quality assessment will be carried out by January 2019; the decisions of Monitoring Committee will be announced in March 2019.

EUSBSR Seed Money

Seed money is EU funding to prepare projects that contribute to one of the priority areas or horizontal actions of the EUSBSR. The Seed money gives an opportunity to draft a project plan that can be further developed into an application to any of the EU or national funding sources.

The next -2^{nd} Seed Money Call will be open in autumn 2019. Taking into account the fact that in next 2 years most of the Interreg funds will be committed and to avoid the situation that seed money projects develop plans without any real funding options, there was agreement to postpone the 2nd call to the latest possible time (end of 2019). In this case seed money would work also as "bridging funding" between the funding periods.

Events related to EUSBSR

The next – 10^{th} Annual EUSBSR Forum will be held on 12-13 June 2019 in Gdansk (Poland) with main focus on circular and sharing economy as response to the demographic changes in the BSR and how these challenges influence such areas as:

- Mobility, labour market;
- Health care and social security systems,
- Social structure, family policy and cultural patterns,
- Production and consumption models
- Use of natural (non-renewable) resources,
- Mature and emerging markets and business sectors.

Call for seminars will be open by mid-December 2018. The organizers will give the priority to the proposals in line with the main theme of the Forum to ensure thematic coherence of the event as well as to the seminars organized more than one EUSBSR coordinator to show the horizontal perspective.

EUSBSR HAC/PAC Coordination meeting will be on 11-12 December 2018 in Warsaw, as the 4th of the 6 thematic modules within the Interreg BSR Programme 2014-2020 project "EUSBSR Support" carried out by HA Capacity. The first module/workshop focused on funding alignment and future options beyond 2020, the second module had a focus on the evaluation and monitoring of HAC&PAC, the third analysed the woking formats of HAC&PAC. The next module will focus on upcoming revision process of the EUSBSR Action Plan.

The regular HAC&PAC *autumn* meeting was held on 26-27 September 2018 in Copenhagen where latest developments within the EUSBSR were presented, e.g., progress on ESPON Territorial Monitoring tool, EU DG Regio statement on EUSBSR AP Revision process, upcomming EUSBSR Annual Forum 2019 in Gdansk, "Let's Communicate!" project support etc.
