# Background

HELCOM and VASAB are co-coordinators of Horizontal Action (HA) Spatial Planning of the EU Strategy for the Baltic Sea Region (EUSBSR). The joint HELCOM-VASAB MSP Working Group acts as the steering committee for the HA Spatial Planning concerning MSP issues. Both Secretariats assist the WG in this role, by e.g. keeping the group informed of activities related to the (EUSBSR) and HA Spatial Planning (such as funding opportunities and meetings) and representing the HA in various meetings and processes as needed.

# Developments and activities related to the EUSBSR and HA Spatial Planning October 2019

HELCOM and VASAB are co-coordinators of Horizontal Action (HA) Spatial Planning of the EU Strategy for the Baltic Sea Region (EUSBSR). The joint HELCOM-VASAB MSP Working Group acts as the steering committee for the HA Spatial Planning concerning MSP issues. Both Secretariats assist the WG in this role, by e.g. keeping the group informed of activities related to the (EUSBSR) and HA Spatial Planning (such as funding opportunities and meetings) and representing the HA in various meetings and processes as needed.

## Revision process of the EUSBSR Action Plan

EC has initiated the Revision process of the EUSBSR Action Plan in order to consider achievements and challenges for both thematic and governance issues, the relevance of Strategy's objectives, sub-objectives and targets, as well as set the future tasks.

In this regard joint HELCOM-VASAB MSP WG emphasised the role of HELCOM VASAB MSP WG group in the EUSBSR framework during its 18th Meeting in Hamburg on 27th of March 2019 and concluded on importance of coordinated role of the group and the need to keep the Horizontal Action in the Strategy.

The revision timetable has been postponed from what was anticipated earlier. According to a new instructions received from EC DG Regio in October 2019, thematic coordinators of EUSBSR (HACs/PACs) are invited to fill in the template for the revision of their respective sections in the EUSBSR Action Plan. The template has been prepared by EC DG Regio and external expert COWI together with EUSBSR National Coordinators and will ensure that the description of PA/HA sections are similar in terms of content and length. A key aim of this revision is to make the EUSBSR Action Plan shorter, simpler and ensure that it is relevant and demonstrates the added value of the HACs/PACs. The deadline for submission of the draft PA/HA description is 1<sup>st</sup> November 2019.

The provisional time line for the future is as follows:

- EC DG Regio sends template + instructions to HACs/PACs by 4.10.2019;
- HACs/PACs draft their contribution by 01.11.2019;
- EC DG Regio and Bettina Rafaelsen will draft a revised version of the rest of the AP;
- EC DG Regio will send HACs/PACs contributions to NC group by 4.11.2019 and an analysis/summary of them (proposal for Action Plan) by 8.11.2019;
- EUSBSR National Coordinators meeting, in the middle of November;
- EUSBSR National Coordinators meeting 27.11.2019 and/or 28.11. 2019 (morning / afternoon)
- December 2019: Further EUSBSR National Coordinators meeting (if necessary)
- January March 2020: Commission internal procedure

The overall goal of the HA "Spatial Planning" is to achieve territorial cohesion perspective in the BSR by 2030. The strategic goal of the HA "Spatial Planning" is to draw up and apply transboundary, ecosystem based maritime spatial plans throughout the Baltic Sea region by 2020/2021.

## Follow-up on funding activities

#### Interreg BSR Programme -

- **Regular project calls** all funds within the current financial framework 2014-2020 are committed. No further calls are planned.
- 2<sup>nd</sup> Call for the project platforms was open from 2<sup>nd</sup> October 2018 till 31 January 2019. VASAB Secretariat's prepared application of Capacity4MSP was approved alongside with two other platform projects. No further platform project calls are planned.
- 2<sup>nd</sup> Call for the extension stage projects is open from 1 October 2019 until 27 February 2020 for Programme priorities No.1-3. Application procedure includes mandatory consultations with MA/JS (open till 13 February 2020) in order to ensure that project idea is in line with the concept of this instrument.
- 2<sup>nd</sup> Seed Money Call is expected to be open on 5 November 2019 23 March 2020 in order to "bridge" current financial framework 2014-2020 with the next one. Applications are expected to prepare project proposals with strategic importance to one of the policy areas or horizontal actions of the EUSBSR. Application procedure will be organized in two steps 1) submission of project idea to relevant PAC/HAC for pre-selection and 2 the

submission of the application to the MA/JS after the applicant has been pre-selected by the PAC/HAC. The preselection procedure within the HA Spatial Planning has been agreed in November 2016. The implementation phase will last up to 12 months and is supposed to end by 30 September 2021.

- **Calls for coordination of EUSBSR** – Call for Applications for the Organisation of EUSSBR Annual Forum 2020 was open from 10 May 2019 – 30 June 2019. City of Turku, being as the only submitted application was decided to be a host for the Forum in 2020.

*Interreg Central Baltic Programme (EE, LV, SE, FI, Åland)* – **5**<sup>th</sup> **Call** open from 15 August – 15 October 2019 for all Specific Objectives. The funding decision will be announced in 2020 January.

*Interreg South Baltic Programme 2014-2020 (DE, DK, LT, PL, SE)* - Currently, no call for proposal of the Interreg South Baltic Programme 2014-2020 is open. The decision about the schedule and scope for the next call will be announced after the Monitoring Committee meeting in April 2020.

*Interreg Europe* – all funds have been allocated to projects. There will be no more calls within current financial framework 2014-2020.
