# Stakeholder Workshop on the application of the draft VASAB Vision 2040

16 May 2022, online

This document summarises the results of the Stakeholder Workshop on the application of the draft VASAB Vision 2040 (called the Long-Term Perspective for the Territorial Development of the Baltic Sea Region, LTP), which took place on 16 May 2022 online. The workshop shared prospects and discussed what implications the updated Vision may have on the ground and how to make it reality. The aim was to identify ways in which the various institutions can contribute to the application of the LTP principles or where they may already be doing so. Another topic for this workshop was the role of VASAB in the EU Strategy for the Baltic Sea Region.

#### Welcome and technical instructions

**Hakan Uraz,** project manager at **REM Consult** and moderator of the workshop, welcomed all participants, provided some technical instructions, and informed about the workshop programme before handing over to Dr. Daniel Meltzian, the current Chair of the VASAB Committee on Spatial Planning and Development of the BSR (CSPD/BSR).

#### VASAB and new draft VASAB Vision 2040

**Dr. Daniel Meltzian, from the German Federal Ministry of Housing, Urban Development and Building (BMWSB),** introduced VASAB and its visions up to the current revision of the LTP. The spirit of the update is to 'bridge the old with the new'. The update is based on work done so far by VASAB and ESPON, and four main spatial elements/metaphors (namely pearls, strings, patches and systems) identified already in the first VASAB Vision drafted in 1994 and analysed in context of potential future developments. The update process is organised in a co-creative, collaborative and participatory approach, during which the key elements of the vision have been developed in close cooperation with the VASAB CSPD/BSR and also communicated to other relevant stakeholders. Feedback is still welcome by mid-summer 2022 and very crucial in further nuancing and refining the










Vision document. Daniel Meltzian explained that the VASAB spatial vision for the Baltic Sea Region in 2040 is structured along four territorial elements represented by *four different metaphors*: the **pearls**, the **strings**, the **patches** and the **systems**. Visions are formulated for each metaphor as well as "Possible Future Actions" (PFA) as ideas for starting points of implementation.

#### Introduction round along the four metaphors

All workshop participants were asked to indicate their organisational background in an online poll. Results showed that, the participants represent the following categories:

- 38% (14 participants) public national authorities
- 19% (7 participants) international governmental organisations,
- 12% (4 participants) public local authorities,
- 12% (4 participants) private sector (SME),
- 9% (3 participants) public authorities and
- 9% (3 participants) NGOs.

An introduction round in break out rooms followed where each participant introduced themself to their peers telling them to which of the four metaphors, they would subscribe themself to and why. Interestingly none of the participants have indicated patches, which should be considered in further communication of this metaphor.

#### Putting the VASAB Long-Term Perspective into practice: Land Sea Act (Interreg BSR)

**Dr. Kristīna Veidemane, BEF Latvia,** presented the Interreg BSR project Land-Sea-Act, as an example on how the implementation of the LTP on the ground can take place. In doing so, she highlighted that both the Land-Sea-Act project and the LTP put special focus on cooperation, (multi-level) collaboration, co-creation and integration – highlighted also by the attendance of participants at


the workshop beyond traditional spatial planner's policy domain, e.g. transport, tourism. Furthermore, not only understanding but also solidarity between actors from different member states seems to be increasingly topical.

#### **VASAB Vision 2040: Options for actions**

Hakan Uraz, REM Consult, highlighted the need for concrete actions, activities and projects, so that the *desirable future becomes a reality*. This is also clearly identified by the LTP's authors and indicated in the VASAB draft LTP Background Synthesis Report (March 2022): "Visions need to be combined with actions. Reflecting on possible desirable futures may easily be turned into daydreaming, lacking concrete focus and direction. Visions need to be combined with actions and vice versa (Böhme and Lüer, 2016). The VASAB 2040 vision shall describe a desirable future and give the overall direction of where the Baltic Sea Region should go. This direction in itself paves the way for coordinated actions and steps to be taken to get closer to the overarching future of the vision. Actions linked to the VASAB vision for 2040 shall inform policy makers to realise this desirable future."

Compared to the previous LTP the updated LTP is thematically rather wide, but also deals with very concrete suggestions for "Possible Future Actions" (PFA), along the four metaphors. These touch one or more of the territorial dimensions and cover a variety of thematic areas.

From the 32 PFAs 21 thematic areas derived according to REM Consult indicating activities and projects that can contribute to the formulated vision.

Hakan Uraz pointed out that planning actors alone will not be sufficient for implementation. Further, the list of PFAs gives valuable ideas to pinpoint concrete activities, however there might be much more. He continued with presenting implementation opportunities. From the audience Integrated Territorial Investments (ITIs) and new Operational Programmes (ESF & ERDF) to be used for transnational cooperation have been added as an option as well.



#### Expert round: New Vision 2040 and VASAB's role as PA coordinator for Spatial Planning

**Elīna Veidemane**, VASAB Secretariat — PA Spatial Planning; **Patrycja Artymowska**, Ministry of Development Funds and Regional Policy, Poland, CSPD/BSR member, **Luciane Aguiar Borges**, Nordregio; **Paulina Szewczyk**, City of Gdynia, Chair of the Planning Cities Commission in UBC and **Dr. Kristīna Veidemane**, Baltic Environmental Forum Latvia, took part in an expert round moderated by Mareike Hannes, REM Consult.



Among others, the following points were expressed during the discussions focussing on the New Vision 2040 and VASAB's role as PA coordinator for Spatial Planning:

- · VASAB as facilitator, knowledge hub and moderator,
- Resiliency and security issues are future topics,
- Avoid overlaps between EU strategies, EUSBSR and VASAB LTP, see VASAB LTP as one leg
  of many of EU strategies,
- The LTP 2040 is explicitly titled as a vision. Thus, it needs to be ambitious and broad in scope to eventually allow to strive for positive impacts.
- Concentrate on specific policy areas first related to spatial planning and move on to others afterwards,
- Differentiate between short to long term actions (elaborate an "implementation plan"),
- First planning document that sets 2040 as time horizon (instead of 2030 or 2050 as usual), so is it long-term this is debatable and depends on the policy area perspective,
- It is of major importance to familiarise stakeholders from different sectors and different levels of governance with the vision and to motivate and activate them to make their own contribution to the implementation of the vision. Thus, also cooperation with other policy areas needed.

### Reflection and main take away for draft VASAB Vision 2040 and further process

Maria Toptsidou, Spatial Foresight, reflected that the update process is open, participatory, and co-creative. It engages stakeholders at different governance levels (EU, BSR and national), including the thematic coordinators of EU Strategy for the Baltic Sea Region, other pan-Baltic organizations, and national and local key stakeholders through series of events and targeted thematic workshops in various networking platforms. The current advanced draft LTP has emerged from this process and is now in the final phase of stakeholder consultation before the new LTP is adopted at ministerial level and acts as a vision for the macro-regional territorial development of the Baltic Sea Region up

to 2040. She highlighted once again that visions are a powerful tool. They necessarily need to be broad, but concrete actions need to follow. To do so different players are needed to take the vision a step further to its realisation.

#### Upcoming activities under German chairmanship & closure

Finally, **Jens Kurnol**, **BBSR**, informed that the LTP 2040 should be completed by the end of 2022 and then adopted at a high-level conference in the second guarter of 2023.
