### Cumulative impacts (NL)

Find a common approach on cumulative impact assessments based on existing work to identify ecological tensions



#### Multiple use of space (D)

Set-up criteria and sharing best practices on co-use



### Nature restoration and conservation (B)

Set-up a program for cooperation regarding conservation, enhancement and restoration of nature



### Long-term perspective of fisheries (FR-D)

Create insight in key fisheries areas and socioeconomic/food impacts of spatial developments at North Sea scale



### Knowledge sharing (NL)

Coordinate the exchange of best practices, (scientific) information, data, plans and assessments.

## Positioning of GNSBI in the network

## An integrated approach succeeds only when in tune with existing frameworks

- Much of the knowledge and decision-making on the North Sea currently happens in numerous (sectoral) bodies and frameworks.
- GNSBI actively reaches out to those existing networks to fill up possible gaps, but also to learn from knowledge and experiences on cross-sectoral decision making through the years.
- One of the prerequisites of GNSBI is to make efficient use of the knowledge and experiences, to prevent unnecessary governance structures or additional workload for the national civil servants.




Figure 1-Indicative representation of existing frameworks and networks relevant for GNSBI.

## Working programme for 2025-2027



The goal of the working programme to gather insight in the objectives, actions and products of the working tracks :



### Monitor track process

The working programme serves as a basis to course-correct when the track does not reach its products and goals or when deemed necessary. Regular monitoring discussions and updates by the (interim-) Secretariat to the steering group, allow the steering group to intervene.



#### Link with other fora

By formulating a working programme, the initiative has the opportunity to communicate its results and working method with existing fora, by setting out the activities per track, the working programme can help with preventing the duplication of work.



#### Foster intra-track discussions

In the working programme, track leaders are invited to think on organising shared workshops and common results or projects. Such projects would lead to experts from different tracks and expertise to mingle and eventually to 'integrated' results, in line with the initiative's goals.

In February 2025, DGs adopted a first version of the working programme. The work program must be updated at least annually, or earlier if deemed necessary by the steering group.
